

While they were at lunch that same day, [REDACTED] was at the lunchroom table playing with his lunch. [REDACTED] seemed to be teasing or taunting Ms. Garrett as if he was going to get up and leave. Ms. Garrett eventually got mad at him, walked over to him, grabbed him by his upper arms from behind and lifted out of his bench seat, placed him on his feet and while still holding him by the arm took him from the cafeteria presumably to the classroom.

On at least two occasions since the beginning of the school year, Ms. Mort witnessed Ms. Garrett strike [REDACTED] on the buttocks with her hand after he had wet his pants. She has also witnessed Ms. Garrett strike [REDACTED] and [REDACTED] on the buttocks with her hand after they would wet their pants. On at least one occasion, Ms. Mort saw a red mark on the buttocks of [REDACTED] as a result of Ms. Garrett's strike to the buttocks even over the impact occurred on his clothes. Ms. Mort also alleged that earlier in the year Ms. Garrett had instructed Ms. Rodriguez and her to take any child in to the bathroom that wet their pants and "you spank their butt." Ms. Rodriguez and Ms. Mort refused to obey that instruction.

Ms. Mort recalled that on another morning this school year, [REDACTED] had been in the classroom and kept uttering "magazine...magazine..." because he wanted a magazine to take along to the bathroom. Ms. Garrett said, "Stop with the magazine, you're not getting a magazine. Ms. Garrett rolled her chair next to [REDACTED]. As [REDACTED] continued his persistence in uttering magazine or every time [REDACTED] would utter the word magazine, Ms. Garrett, at first, would tap him on his cheek with a closed fist. This occurred several times. Then, Ms. Mort said that Ms. Garrett repositioned herself so that she was along side of [REDACTED]. At that point, when he would utter the word magazine, she would raise her arm and with the elbow of her raised arm would tap his chin with her elbow.

Ms. Mort stated that she had knowledge of an incident that occurred during a previous school year whereby a student's teeth were damaged by Ms. Garrett but had no personal knowledge of that incident.

Ms. Mort stated that the aforementioned incidents were only a portion of incidents where she has witnessed Ms. Garrett using inappropriate techniques and/or physical force on the children. Based on Ms. Mort's training and experience the articulated events and observations, none of described actions are consistent with her training or experience.

Ms. Mort stated that on one more occasions she has witnessed [REDACTED] hit himself on his head with his hand because he can't see what's going on...only hear the tones of a person's voice. In response to [REDACTED] actions, Ms. Mort has witnessed Ms. Garrett say, "You stupid little ass...if you want to keep banging yourself on the head, then go ahead...because you deserve it." Ms. Mort has mentioned to Ms. Garrett that she shouldn't make those comments to the students because they might go home and tell their parents and the teacher is the one who will be responsible. Ms. Garrett's response to her suggestion was, "Ah, none of these little shits will never go home and say anything. Ms. Mort said that the comments containing foul language were loud enough to be heard throughout the classroom.

Ms. Mort stated that Ms. Garrett uses foul language frequently toward and in the presence of students, around Ms. Mort with such words as dumb ass, jackass, etc. Ms. Mort stated that at no time during the events she described were children such a danger to her as to warrant the use of physical force she observed. And that, none of the physical force or restraints used by Ms. Garrett were accepted methods of control based on her training and experience.

Prior to the conclusion of the meeting, Ms. Mort mentioned that she had been involved in conversations with Ms. Garrett where Ms. Garrett would talk about and/or describe her sexual activities as a Dominatrix. During one or more of these conversations students were present in the classroom but working on tasks at their work areas. Ms. Mort also mentioned that while in the classroom on at least one occasion Ms. Garrett has shown her pictures depicting Ms. Garrett with bare breasts and pierced nipples. She also learned that Ms. Garrett's Internet screen name was "Nautitcr4U."
